# **COURSE DESCRIPTION**

**CCE150EX (0.5) Cultural Immersion Experience** will be completed through an international or stateside immersion into a culture that is significantly different from the student's primary culture.

Prerequisite:	The CCE150 course MUST be completed prior to participation in the CCE150EX Cultural Immersion Experience.	
Location:	The location of the intended Cultural Immersion Experience is to be proposed by the student and approved through the Cross-Cultural Engagement Office prior to participation in the Cultural Immersion.	
Duration:	The Cultural Immersion Experience into another culture must be a minimum of 6 nights and 7 days.	
Proposal: Pre-Approval:	A Proposal of Intent form detailing the intended Cultural Immersion must be submitted and approved by the Cross-Cultural Engagement Office <i>PROR</i> to the Cultural Immersion. The Proposal includes a Rubric "Quiz" to aid the student in verifying the immersion contains enough cultural components to qualify for a Cultural Immersion Experience. A cultural experience will NOT be eligible to be considered for the CCE150EX Cultural Immersion Experience if pre-approval has not been granted. This pre-approval must be granted PRIOR to participating in the cultural experience.	
Enrollment:	Students will be enrolled in the CCE150EX course upon submission and approval of their Proposal of Intent.	
Assignments:	Two post-immersion assignments must be completed by January 31/August31 of the semester following the Cultural Immersion.	

#### POST-IMMERSION ASSIGNMENTS

- Assessment: A follow-up CQ assessment must be completed after returning from the Cultural Immersion. This will serve as a comparison to your assessment completed at the beginning of your CCE150 course. The link is listed on Discovery.
- **Reflection Paper:** A 2500-word Cultural Reflection Paper will be submitted on Discovery. This paper should integrate concepts presented in the CCE150 course along with the Cultural Immersion interactions and observations. Specific topics to be included in the paper are listed on Discovery.

## DEADLINES

The deadline for the post-immersion assignments will be the semester following the Cultural Immersion: January 31 for immersions taken during the previous fall semester or winter break, and <u>August 31</u> for immersions occurring during the previous spring semester or summer break. Students who do not complete the post-immersion assignments by the deadline will have a hold placed on their class registration for the next semester.

## INTERNATIONAL & THIRD CULTURE STUDENTS

International and approved Third Culture students may use their experience in the United States as their Cultural Immersion Experience. It is recommended they complete the CCE150 course within their first 2-3 semesters of enrollment at Asbury, and upon completion they will then be enrolled in CCE150EX. The deadline for completion of CCE150EX will be the semester following the completion of their CCE150 course: January 31 for those who completed CCE150 during the previous fall semester, and August 31 for those completing the CCE150 course during the previous spring semester.

## TRANSFER STUDENTS

Students with more than 60 transferred credits at the time of matriculation (not counting AP and college credits earned prior to high school graduation) may be considered for a waiver of the CCE150EX Cultural Immersion, but not the CCE150 course.

#### **STUDENT LEARNING OUTCOMES**

CCE150 Cultural Engagement and Responsibility and CCE150EX Cultural Immersion Experience are key components of Asbury's institution-wide initiative, Embrace. This two-part course requirement is developed to enhance the student's learning experience at Asbury. The following is a representation of the learning outcomes: Student Learning Outcomes
